Leaders have recognized the growing affinity between data and application integration. They are approaching location-agnostic deployments in a halting manner. Providers or solutions not limited to only cloud or only on-premises that can be deployed beyond a specific location are gaining traction (that is, on devices, as agents/daemons on sensors, in the IoT and more). Leaders have an established market presence, significant size and a multinational presence — either directly or through a parent company.”¹
